Transfer of fund units

In order to transfer fund units a written request (including all necessary information) is required. A request for transfer of fund units in ODIN Norden, ODIN Norge, ODIN Sverige, ODIN Europa and ODIN Eiendom the cut off time is 12.00 (GMT+1). For transfer orders placed before 12.00 (GMT+1) you will receive unit value calculation the same day.

A request for transfer of fund units in ODIN Global and ODIN Emerging Markets the cut off time is 15.00 (GMT+1). For transfer orders placed before 15.00 (GMT+1) you will receive unit value calculation the following day. For transfers to or from a fund with a global mandate, the cut off time is 15.00 (GMT+1) (to receive unit value calculation the following day). Please be advised that due to the delay in settlement date of the global mandates, the unit holder is subject to an exchange risk.

Redemption in connection with a transfer is regarded as a sale for tax purposes.

The notice may be sent in by post, fax or an electronic service approved by ODIN Forvaltning AS. Confirmation of the transfer will be sent to unit holders by the Central Securities Depository (VPS) after approximately one week. ODIN Forvaltning AS is not responsible for any loss or harm that its clients suffer in connection with the determination of the unit price which are caused by circumstances outside the company's control, such as power cuts, strikes, errors in computer processing systems or telecommunications networks or errors committed by parties used by the company to fulfill its obligations under a contract.
