The fund's assets are to be invested in small and medium-sized enterprises based in the Nordic region, with an emphasis on Sweden, and whose shares are available to be traded through a commercial centre in the EEA. Small and medium-sized enterprises based in the Nordic region refer to companies that have their registered office or headquarters in a country in the Nordic region, and which on the date of the fund's acquisition have a market value not in excess of one (1) per cent of the total market value for all shares quoted on the Nasdaq OMX Stockholm (the Stockholm Stock Exchange). The selection of shares and the distribution between different industries and regions is otherwise not predetermined, which means that the fund's holdings may from time to time be concentrated to just a handful of industries. This fund is classified as a fund that promotes, among other characteristics, social and environmental characteristics as defined in Article 8 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services

What are the risks and what could I get in return?

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last ten years. What happens if ODIN Forvaltning AS in unable to pay out?

The fund's assets are not kept by the management company. In line with the legal requirements, the fund's assets are kept with a special custodian appointed by the management company. If the fund management company comes under bankruptcy proceedings, the management of the fund will be transferred to another management company. There is no compensation or guarantee scheme for fund savings.

What are the costs?

Costs over time
