What is this product?

Type	Mutual fund
Term	The product has no maturity date. The fund management company is entitled to terminate the fund and redeem units, for further information see the prospectus
Objective	The fund's assets shall be invested in securities with a European connection, or issued by a European company, regardless of the currency in which the security is issued. The manager determines the average interest rate duration for the fund's holdings, taking into account market conditions. The fund's average interest rate duration is in the range of 0-5 years. The fund's assets shall be invested in compliance with the LVF in addition to these fund regulations. The fund adheres to specific sustainability criteria in connection with investments. The fund does not invest in companies that violate international conventions or in companies that produce and/or distribute controversial weapons. Furthermore, the fund does not invest in companies where more than 5 per cent of the company's turnover comes from the production and/or distribution of goods and services in the categories of tobacco, alcohol, weapons, gambling or pornography. In addition, the fund has a restrictive approach to investments in companies that extract fossil fuels (coal, oil and gas). Furthermore, the fund takes into account such additional criteria as decided by the fund company. This fund is classified as a fund that has sustainability as its purpose as defined in Article 9 of Regulation (EU) 2019/2088 on sustainability-related disclosures in the financial services sector.
Target group	The product may be suitable for investors with an investment horizon of minimum 2 years, who understand that their investment may increase or decrease in value and that some or all of their investment may be lost. No special knowledge of funds or financial markets is required to invest in the fund.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 2 out of 7, which is low. This rates the potential losses from future performance as low.

Risks not covered by the risk indicator: Counterparty risk - occurs if a counterparty does not meet its obligations to the fund, for example by not paying an agreed amount or not delivering securities in accordance with the agreement. Operational risk - the risk of loss due to, for example, system failure, human error or external events. This product does not include any protection from future market performance so you could lose some or all of your investment.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last ten years. Markets could develop very differently in the future. What happens if Odin Forvaltning AS is unable to pay out?

The fund's assets are not kept by the management company. In line with the legal requirements, the fund's assets are kept with a special custodian appointed by the management company. If the fund management company comes under bankruptcy proceedings, the management of the fund will be transferred to another management company. There is no compensation or guarantee scheme for fund savings.

What are the costs?

The advisor or distributor who sells you this fund may charge you more costs than those shown here. If so, the advisor or distributor must provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different investment periods. We have assumed:

- If you redeem during the first year, you will get back what you have invested (0% annual return) For other investment periods, we have assumed that the product performs in line with the moderate scenario.
